PREREQUISITES FOR PREFERENTIAL ELIGIBILITY FOR CAMPUS PLACEMENT

Following requirements are declared as preferable for students to become eligible for campus placement.

- 1) As a part of eligibility for the appearing of students for campus placement, the students who have joined BVM Engineering College (Autonomous) **from 2016 entry onwards** must have undergone skill training through **ANY ONE** (minimum requirement) out of the following two options.
 - a) Industry Readiness Training Program organized by T & P Cell under TEQIP-III. It was conducted recently from 29-05-2018 to 03-06-2018. It will be offered in every Summer vacation for a week (six days).
 - b) Employability Skill Training from Professional Companies under TEQIP-III to be organized from July 2018 for pre-final year students. It will be offered separately in both the semesters during the tenure of TEQIP-III.

This activity is as a part of employability skill training under AICTE mandate. The copy of the certificate after successful completion shall be provided to Faculty Advisor and T & P Office for record. Both of above training programs will have industry experts as trainers. The certificates will be considered equivalent to one week of internship/industrial training under six weeks mandatory scheme of BVM Autonomous Regulations.

- 2) **For 2016 entry onwards, ANY ONE** NPTEL Course out of the following six or any other similar course offered from NPTEL in future.

3) For 2016 entry onwards, for non CP/IT/EC branch students to appear in campus placement of any IT/Software company. **ANY ONE** of the following NPTEL Courses or BVM Autonomous Open Elective for basic programming and coding skills is compulsory.

The requirements mentioned at 1) and 2) above are preferable to be eligible for Campus Placement at BVM for all companies. The requirement 3) above is preferable for IT/Software companies for other than IT/CP/EC branch students to be eligible.

Moreover, following rules are to be implemented for campus placement process for which a undertaking will be taken from the student with sign of his Parents and Departmental TPC Faculty Coordinator (for information):

1. Whenever any google form survey for showing interest in appearing for any company coming for campus placement is floated and student gives his consent in this form to appear for the written test or interview, and do not appear for the same, then his bio-data will not be submitted to any further companies and he will be banned from further placement process.
2. After getting the appointment letter, if a student do not join the company then disciplinary action will be taken against him like forfeiting his degree certificate by informing the Academic Section and University.
